- 6.1 County Cllr Miller noted the following.
 - the sign at the school was still not working and he would report this issue to the County Council at the earliest opportunity.
 - Rob Stepenieszki from WCC is looking into the possibility of a trial from Airband in the Hanbury Parish area to improve mobile signal.
 - Resurfacing of Pumphouse Lane is on Highways list but is a low priority.
 - AM to donate £500 towards The Kings coronation celebrations.

Location: Land at (OS 9572 6281), Salt Way, Hanbury

Description of Proposal: Club House with external toilet facilities and a new access road and additional parking.

The Parish Council objected to this application in the green belt. The number of spaces required (60) are too high for this narrow country lane.

Concern was also raised re the amount of people potentially using the composting toilets.

It was also noted that if Wychavon permits this application, then a caveat MUST be recorded on the planning conditions that if the club fails then this field MUST return to agriculture and not be allowed to be converted to housing.

This application is in the green belt and not near the designated settlement boundary of Hanbury.

Location: Land Off Loggerheads Land And, Salt Way, Hanbury Description of Proposal: Portal steel framed building

The Parish Council were sorry to see the poor quality of the application.

The location map was minimal, there was no reference to the entrance position.

The length of the building was also not noted.

The Parish Council objected to this lack of information and this application.

Location: Land and Buildings At (OS 9520 6255) Mere Green, Salt Way, Hanbury.

Conversion of commercial building into a live/work unit and associated works.

The Parish Council objected to this application.

Concern re the mains gas pipeline have not been resolved.

This is not in a sustainable area, references to bus services etc are overstated.

Grossly unsuitable for conversion industrial building.

The proportion of the live-work living is not appropriate.

8.1 <u>Village Hall</u>

- The Village Hall were pleased that the PC would pay 50% towards the replacement of the fire exit and this would be done soon.
- The lock on the front door would also be replaced.
- It was noted that the hedge adjacent to the car park of Byways needed cutting back. Chris Cooke to be asked to do it and will liaise with NC.

8.2 Coordination Group

The next meeting will discuss any activity for the Coronation.

8.3 Pavilion Committee

- A cleaner has been employed by the Pavilion Committee to clean the pavilion once a fortnight.
- SIM card for the router at the pavilion is to be purchased at around £60 plus £10 a month.
- A sign like the village hall sign is to be purchased at around £330. To be placed
 in the hedgeline. AM suggested that highways should check the spot prior to
 installation.
- The car park barrier for the recreation ground is to be followed up by JE.

8.4 <u>Conversion of part of the village hall field - to parking</u>

- Speed checks were performed at the potential location. The speeds mean that a
 visibility splay of 116m up and down the hill would be necessary. The splay will
 also need to be 2.4m back from the road (from verge to highway) A working
 party is to be set up to look into the possibility of a car park at this location. To
 include members of the VHMC and Clare Stallard.
- Only 12% of vehicles were travelling at or below the speed limit.

8.5 <u>Memorial Gardens</u>

- Planning approval is needed for the installation of a fence at this location. MAB to submit on behalf of the Council.
- Solicitor regarding the contract for Byways and The Parish Council is ongoing.

8.6 <u>Mobile signal in Hanbury.</u>

- Lizzie Evans asks HPC if they would prefer fliers advertising the petition in the Hanbury Herald at a cost of £56 or a QR code in the Herald. HPC asked for a QR code.
- Rachel Maclean MP has written to the Science technology and Innovation Secretary asking for them to look at a small cell 5G solution.
- AM noted that the County Council were aiming to have 100% coverage of mobile signal.
- 8.7 Coronation celebrations May 2023
- 8.8 School sign update

AM noted that the non-functionality of this device due to the poor mobile signal was being investigated.
