Resident comments on the Bridge on Forest Lane/Wall House Lane.

"This bridge is the scene of several accidents every year – The Police insist that the bridge is wide enough for 2 vehicles to pass and nothing can be done to improve it. The particular issue is that the bridge is on a blind partial corner - so cars (mostly going too fast) cannot keep close into their lane - so swing out and cause collisions or lose control.

If a wider bridge is unrealistic, perhaps better signage (or a strict priority system to one side or the other) would help. Also, if the vegetation/trees on the south side of the road could be reduced (say to 30m along the stream), that would improve the sight line for vehicles coming in both directions - and make collisions less likely".
